

HughesNet “Go Green Newsletters” Sweepstakes OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The HughesNet “Go Green Newsletters” Sweepstakes (“Sweepstakes”) will begin at 12:00:01 am Eastern Time (ET) on March 30, 2015 (“Sweepstakes Start Date”), and ends at 11:59:59 pm ET on May 15, 2015 (“Sweepstakes Period”). Entries must be received and recorded by Sponsor's computer during the Sweepstakes Period. Sponsor's computer is the official timekeeping device for this Promotion.

SPONSOR/ADMINISTRATOR: The Sweepstakes is sponsored by Hughes Network Systems, LLC, 11717 Exploration Lane, Germantown, MD 20876 (the “Sponsor”) and administered by American Sweepstakes & Promotion Co.
